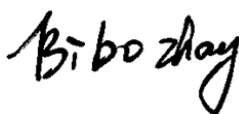

The frequency range covered is 0 Hz to 300 GHz.

4. CLASSIFICATION OF THE ASSESSMENT METHODS

According to User manual, the antenna of the product is at least 0.2m away from the body of the user. Warning statement to the user for keeping at least 0.2m separation distance and the prohibition of operating to a person has been printed on the user's manual. So, this product under normal use is located on electromagnetic far field between the human body.

Far Field Calculation Formula
